#### A. 職業退休計劃統計數字概要

##### ORSO Schemes Statistical Highlights

截至2004年6月30日，總共有8,125個職業退休計劃，包括6,108個職業退休註冊計劃及2,017個職業退休豁免計劃。在這8,125個職業退休計劃中，有5,456個計劃獲強積金豁免。下列的統計數字可較全面地分析這些計劃的特點。

As at 30 June 2004, there were 8,125 ORSO schemes, comprising of 6,108 ORSO registered schemes and 2,017 ORSO exempted schemes. Out of these 8,125 ORSO schemes 5,456 schemes were exempted from MPF requirements. The following statistics are compiled to give a more comprehensive picture of the characteristics of these schemes.
