A. 職業退休計劃統計數字概要

ORSO Schemes Statistical Highlights

截至2007年12月31日，總共有7,445個職業退休計劃，包括5,336個職業退休註冊計劃及2,109個職業退休豁免計劃。在這7,445個職業退休計劃中，有4,804個計劃獲強積金豁免。下列的統計數字可較全面地分析這些計劃的特點。

As at 31 December 2007, there were 7,445 ORSO schemes, comprising of 5,336 ORSO registered schemes and 2,109 ORSO exempted schemes. Out of these 7,445 ORSO schemes 4,804 schemes were exempted from MPF requirements. The following statistics are compiled to give a more comprehensive picture of the characteristics of these schemes.
