Dear Responsible Officers,

Revised MPF Guidelines and Forms for Registered Intermediaries (RIs)

The Mandatory Provident Fund Schemes Authority (MPFA) has recently amended the following two sets of Guidelines:

- 1. Guidelines on MPF Intermediary Registration and Notification of Changes (Guidelines VI.1); and
- 2. Guidelines on Annual Returns to be Delivered by Registered Intermediaries (Guidelines VI.3).

With the commencement of operations of the Insurance Companies (Amendment) Ordinance 2015 (Amendment Ordinance) on 26 June 2017, the Insurance Authority (IA) took over the statutory functions of the Office of the Commissioner of Insurance to regulate insurance companies. The English name of the IA remains unchanged while its Chinese name is changed from "保險業監督" to "保險業監管局" as stated in the Amendment Ordinance. All forms (including

Form INT-1 to Form INT-5 and annual returns for RIs) included in the two sets of Guidelines were amended to reflect the changes. Similar changes are also made to Form INT-6 and Form INT-7. In addition, we have made some textual amendments to various parts of the forms for housekeeping purposes.
