# **II.3** Guidelines on Quarterly Returns of Constituent Funds

#### **INTRODUCTION**

Section 6H(1) of the Mandatory Provident Fund Schemes Ordinance ("the Ordinance") provides that the Mandatory Provident Fund Schemes Authority ("the Authority") may issue guidelines for the guidance of approved trustees, service providers and other persons concerned with the Ordinance.

- 2. Section 6H(3) of the Ordinance provides that a guideline may require persons (including persons belonging to a class) specified in the guideline to give to the Authority information or documents of a kind specified in the guideline. The guideline may only specify information or documents of a kind that the Authority reasonably requires for the exercise or performance of its functions.
- 3. The Authority hereby issues guidelines to specify the information required to be submitted in respect of quarterly returns of constituent funds. These guidelines also specify the means by which the quarterly returns should be submitted to the Authority.

# **QUARTERLY RETURN**

#### **Contents of the Quarterly Return**

4. The contents of the quarterly return of a constituent fund are set out in the Annex (FORM CF(QR)). The information to be provided should be in respect of the end of each calendar quarter.

### **Submission of Quarterly Return**

5. The approved trustee of a registered scheme is required to submit the quarterly return within 6 weeks of the end of each calendar quarter either by electronic means (such as e-mail or diskettes) or in hard copies to:

#### **Definitions of Terms**

6. Except where otherwise specified in the Annex, the terms common to the Ordinance and the subsidiary legislation of the Ordinance carry the same meanings as defined in the Ordinance and the subsidiary legislation. Approved trustees of registered schemes should make appropriate reference to the Ordinance and the subsidiary legislation, where necessary.
