







On the other hand, subsidiary intermediaries are assigned to their principal intermediary's frontline regulator and some subsidiary intermediaries may be attached to more than one principal intermediaries that were not attached to any principal intermediary outnumbered subsidiary intermediaries that were attached to more than one principal intermediary, the number of subsidiary intermediaries was larger than the total of subsidiary intermediaries by frontline regulator.




Chart II.4.1 Percentage Share of Aggregate Net Asset Values* by Fund Type -30 September 2024

Chart II.4.2 Investment of Approved Constituent Funds*: Deposits and Cash by Currency Breakdown – 30 June 2024





圖 II.4.3 按貨幣劃分投資於債務證券的核准成分基金資產分配 * - 2024 年 6 月 30 日

Chart II.4.4 Investment of Approved Constituent Funds*: Equities by Geographical Region¹ – 30 June 2024





圖 II.4.5 按基金種類及資產類別劃分的核准成分基金資產分配* -2024 年 6 月 30 日




圖 II.6.2 按基金種類劃分投資於「預設投資」成分基金的強積金 資產*

Statistics on the number of approved trustees, registered schemes, approved constituent funds and registered intermediaries were compiled on the basis of the records kept by the MPFA. For the statistics on the enrolment and total number of scheme members in the MPF schemes, contributions received, benefits paid, Net Asset Value and Fund Expense Ratio of approved constituent funds, they were compiled on the basis of regular information submitted by the trustees and the eMPF Platform Company Limited to the MPFA.

ORSO Registered Schemes

Statistics on the asset value and annual contribution amount of ORSO registered schemes were compiled on the basis of the latest annual returns filed with the MPFA in respect of the ORSO registered schemes.
