Interested employers can simply apply online. Employees or MPF intermediaries are welcome to nominate eligible employers by submitting the nomination form online.





What does it take to be a Good MPF Employer?

申請資格 Eligibility

積金好僱主為年度嘉許計劃，涵蓋2023年4月1日至2024年3月31日。僱主符合以下條件便可申請。

The Good MPF Employer Award is granted on an annual basis, covering the period from 1 April 2023 to 31 March 2024. Employers who fulfil the following criteria are eligible to apply for the Award.

合資格的僱主須於計劃年度內

Eligible employers should fulfil the following criteria within the Award year



參加強積金計劃達一年
Participated in an MPF Scheme for at least one year



為僱員參加計劃及準時供款
Enrolled employees in an MPF scheme and made contribution on time



提供以下最少一項額外退休保障：
Provided at least one of the following extra retirement benefits for employees:



提供多於一個強積金計劃
Offered more than one MPF scheme



為僱員作出自願性供款
Offered MPF voluntary contributions for employees



提供與強積金有關的其他退休福利*
Offered other retirement benefits related to the MPF*

* 例：仍為65歲以上員工供強積金
* e.g. offered MPF contributions for employees aged over 65

特別獎項 Special Awards

為特別表揚及公開嘉許多年不斷優化僱員退休保障的「積金好僱主」，僱主如符合相關條件，將會自動獲頒以下殊榮：
To specially commend and give public recognition to employers that have made continuous efforts to further enhance the retirement protection of their employees, employers who fulfil the relevant requirements will be presented with one or more of the following awards:



全能積金好僱主 Best All-round MPF Employer

連續十年獲嘉許為「積金好僱主」
Received the Good MPF Employer Award for 10 consecutive years

提供多於一個強積金計劃
Offered more than one MPF scheme

為僱員作出自願性供款
Offered MPF voluntary contributions for employees

榮獲「電子供款獎」及「積金推廣獎」
Received the e-Contribution Award and MPF Support Award

僱主如符合條件參加「積金好僱主」嘉許計劃，可同時申請以下兩個特別獎項：

Employers fulfilling the criteria for the Good MPF Employer Award can apply for the following two special awards at the same time:



電子供款獎 e-Contribution Award

僱主須在計劃年度內的任何三個月或以上，透過電子方式遞交強積金供款資料或繳付強積金供款；及以網上或電子方式遞交嘉許計劃的申請。

Employers must have submitted contribution data or made contribution payments electronically for three months or more and use online methods to submit application for this year's Award.



積金推廣獎 MPF Support Award

僱主須在計劃年度內，向僱員提供最少兩項與管理強積金相關的協助，例如：為僱員發放有關「積金易」平台的最新資訊、安排講座、提供資訊、協助管理帳戶等。

Employers must have provided their employees with at least two kinds of support services (e.g. provided employees with the latest information about the eMPF Platform, MPF talks, MPF information, assistance in account management, etc) to help them manage their MPF during the Award year.



積金好僱主10年 Good MPF Employer 10 Years

連續十年獲嘉許為「積金好僱主」
Received the Good MPF Employer Award for 10 consecutive years



積金好僱主5年 Good MPF Employer 5 Years

連續五年獲嘉許為「積金好僱主」
Received the Good MPF Employer Award for 5 consecutive years
