

I. 就業人口

The Employed Population

根據香港特別行政區政府統計處公布之 2019 年第 3 季《綜合住戶統計調查按季統計報告》,在本港 386 萬就業人口中,僱員及自僱人士」的數目分別佔 351 萬及 34 萬,另外約有 9 000 人為無酬家庭從業員。

According to the Q3 2019 Report on General Household Survey published by the Census and Statistics Department, HKSAR, Hong Kong's employed population of 3.86 million was made up of 3.51 million employees and 0.34 million self-employed persons¹ (SEPs). In addition, around 9 000 persons were unpaid family workers.

在就業人口中,有74%獲強積金計劃保障,11%受其他退休計劃保金開如公務員退休金計劃及獲強積金的稅業退休計劃等。13%就業人口並沒有法律責任參加任何本地員人65歲以上或18歲以下的僱員其餘2%的就業人口為應參加強積金計劃但尚未參加的人士。

Among the employed population, 74% are covered under MPF schemes and 11% are covered under other retirement schemes, such as Civil Service Pension Scheme, and MPF exempted ORSO schemes, etc. Thirteen percent of the employed population, most of them domestic employees and employees who are aged above 65 or below 18, are not required to join any local retirement scheme according to law. The remaining 2% of the employed population are people who should have joined MPF schemes but have not done so.









Chart III.4.2 Asset Allocation of Approved Constituent Funds* by Fund Type and Geographical Region¹ – 30 September 2019





圖 III.4.3 按基金種類及資產類別劃分的核准成分基金資產分配* - 2019 年 9 月 30 日



Categories of Accounts *




圖 III.6.2 按基金種類劃分投資於「預設投資」成分基金的強積金 資產*
