#### A. 職業退休計劃統計數字概要

##### ORSO Schemes Statistical Highlights

截至2013年12月31日，總共有5,103個職業退休計劃，包括4,230個職業退休註冊計劃及873個職業退休豁免計劃。在這5,103個職業退休計劃中，有3,868個計劃獲強積金豁免。下列的統計數字可較全面地分析這些計劃的特點。

As at 31 December 2013, there were 5,103 ORSO schemes, comprising of 4,230 ORSO registered schemes and 873 ORSO exempted schemes. Out of these 5,103 ORSO schemes 3,868 schemes were exempted from MPF requirements. The following statistics are compiled to give a more comprehensive picture of the characteristics of these schemes.
