積金局舉辦「積金好僱主」嘉許計劃，以：

- 推動及促進僱主遵守強積金法例
- 鼓勵僱主為僱員提供更佳的退休福利
- 嘉許致力保障及加強僱員退休福利的模範僱主

The MPFA has launched the Good MPF Employer Award ("the Award") to:

- Promote and foster compliance with MPF legislation by employers
- Encourage employers to provide better retirement benefits for their employees
- Recognize employers who are exemplary in enhancing the retirement benefits of their employees

Eligibility

僱主須已參與強積金計劃一年或以上（截至2016年3月31日），並於2015年4月1日至2016年3月31日內符合以下條件：

- ✓ **履行僱主的法定責任**
遵守強積金法例
- ✓ **為僱員提供額外退休保障**
符合以下最少其中一項條件：
 - 提供多於一個強積金計劃供僱員選擇
 - 為僱員作出強積金自願性供款
 - 在強積金制度下為僱員提供其他形式的退休福利

Employers must have participated in an MPF scheme for at least one year (as of 31 March 2016), and also fulfilled the following criteria in the period from 1 April 2015 to 31 March 2016:

- ✓ **Compliance with Employer's Statutory Obligations**
Employers must have complied with the MPF legislation
- ✓ **Provision of Better Retirement Protection for Employees**
Employers must have fulfilled at least one of the following criteria:
 - Offered more than one MPF scheme for employees to choose from
 - Offered MPF voluntary contributions for their employees
 - Offered other forms of retirement benefits for their employees under the MPF System
